




#### **CLUB PURPOSE**

1988 was a very good year!

Ronald Reagan was completing his term as president, and George H.W. Bush was elected to succeed him.

Due to the industry downturn in the early eighties, I believe our membership was between 60 and 70 members. Our board consisted of 15 members = President, 1<sup>st</sup> VP 2<sup>nd</sup> VP, Treasurer, Correspondence Secretary, Recording Secretary and 8 Directors. Directors served 2 year terms - with 4 being elected each year; thus four directors retired and four new ones came onto the board.

### THE MANUEVERABILITY OF LIFTBOATS IN THE GULF OF MEXICO AND BEYOND

#### **MARCH 2010 PROGRAM**

I, Susan Miller, a member of the Westbank Desk and Derrick spoke at their May meeting. As an employed with Laredo Offshore Services in Belle Chasse, Louisiana I gave an overview of my company's services.

Laredo Offshore Services currently has four liftboats or jackup boats, two derrick barges and one material barge.

The jackup boats have GPS and Z drives which easily maneuver them adjacent to the offshore rigs or platforms. They jack up and down the legs of the boat to the desired height of the platform. These vessels are manned by Laredo personnel, the captain, mate, cook, able bodied seamen and two ordinary seamen who are all Coast Guard licensed and TWIC card holders. Also on board might be the subcontractors, the divers, welders, etc. These vessels can sleep up to thirty-eight people at a time with all the amenities of home, including internet, with a private room for the captain, company man and cook who have to get up early in the morning.

The derrick barges and material barge are manned by the Laredo Construction Company. The construction yard is in Galveston, Texas. At times the Laredo Construction Company crew are on board the jack-up boats as needed.

Two of these vessels had the opportunity to work in the Bahamas repairing some bridges last summer. Everyone in the company wanted to work this hitch. It was a twenty-eight day hitch unlike the other hitches which are fourteen days on and fourteen days off. It was a crew change nightmare, but as always, it worked out.

Laredo is a family owned company and a good company to work for.




cross the Causeway stay on Hwy. 190 West towards Covington From Baton Rouge, Hammond, Slidell...on I-12:






