

The Price of Oil

The hottest topic of today is the price of gasoline at the pump. Everyone is conscious and comparing the price per gallon each day as they commute to and from work, or run errands. It is headline news. A barrel of crude oil is nearly reaching \$135 with no end in sight. Everyone believes that the oil companies are the culprits of high prices. Before pointing the finger and placing blame, here are a few questions we must answer.

Where does gasoline come from? Oil was formed from the remains of plants and animals that lived and died long ago in a marine environment before the dinosaurs. Over the years, the remains were covered with sediment. Heat and pressure from these layers helped the remains turn into what we today call crude oil. A typical yield for a barrel of crude oil is equivalent to 42 gallons. Out of that barrel; 20 gallons is made into gasoline, with the help of the refining process that heats the crude so that the heavy part of the oil can be processed; otherwise there would only be 10 gallons for gasoline. The remaining barrel contains 10 gallons that make diesel; 5 gallons make up liquid petroleum gas, heating oil, and heavy fuel oil, 4 gallons made into jet fuel. The rest is made into other petroleum products. The United States is the world's third largest producer. The Alliance Refinery currently processes 260,000 barrels of crude daily with a 90% clean product yield which include gasoline, jet fuel, and diesel. In volume, more barrels leave the refinery than are brought in.

The top five crude oil-producing countries are: Saudi Arabia, Russia, United States, Iran, and China. Over one-fourth of the crude oil produced in the United States is produced offshore in the Gulf of Mexico. The top crude oil-producing states are: Texas, Alaska, California, Louisiana, and Oklahoma. Thirty-one states have crude oil reserves, including the Pacific coastline. Many of these reserves have gone untouched due to the citizens of these states choosing not to allow on or offshore drilling. We've heard it time and time again, "Not in my backyard!"

The amount of crude oil produced domestically in the United States has been getting smaller each year. However, the use of products made from crude oil has been growing, making it necessary to bring more oil in from other countries. The United States currently imports 60% of its crude oil needs, so what distribution system is used? The imported crude comes from the Persian Gulf Region (18%), Africa (22%), the Western Hemisphere (48%) and 12% from other areas. The crude is distributed by ship, pipeline, and truck. These costs are astronomical.

What are the components that make up the gasoline price at the pump? The cost of crude oil, as a share of the retail, price varies over time and among regions of the country. Today the price of crude oil averages about \$135 per barrel and accounts for about 58% of the retail price. Federal and State taxes account for 15%, refining costs are 17%, distribution and marketing 10%. So when you do the math one gallon of crude oil from a barrel alone costs \$3.22.

What impacts the price of gasoline? Retail gasoline prices are mainly affected by crude oil prices and the level of gasoline supply relative to demand. Since 60% of our crude comes from outside this country, unfortunately there are supply disruptions that can cause drastic price increases. Even when crude oil prices are stable, gasoline prices fluctuate due to seasonal demand and local retail station competition. Prices tend to gradually rise in the spring and peak in late summer when people drive more, then drop in the winter. Gasoline prices can change rapidly. If something disrupts the supply of crude oil or if there are problems at refineries or with delivery pipelines, we notice it quickly at the pump.

The United States consumes 21 billion gallons of gasoline every day, in 210 million vehicles, traveling 7 billion miles per day. There are only 300 million people in the United States. This is a significant amount of energy being used each day by just one country. What are ways to drive more efficiently? The next time you are out on the highway, remember that you burn less fuel by driving under 60 mph. If you must venture out for errands, try one-stop shopping. Start a carpool for work or school. Keep your tires properly inflated and perform routine maintenance on your vehicle.

What is the path for the United States to energy security? We must find and invest in alternative fuels such as coal, natural gas, nuclear electric power, and other renewable energy such as solar, geothermal, biomass, hydroelectric and wind energy. The United States is the largest producer of coal, but coal is not considered a clean fuel.
