





Expired coupons work.

Save 'em whether they're active or expired! We'll send both. Coupons can be used on overseas military bases for up to six months past their expiration date.

Military families benefit.

Many military families rely on donated coupons to help offset the expense of living overseas.

#### - Bagging Instructions -

- Cut out the coupons (Not expired more than 3 months). Please note that the bases will not accept them unclipped because they don't have the manpower to clip them.
- Sort them into piles by type:
  - a. Food items (Pet food counts a Food)
  - b. Non-food items
- c. Baby supplies are 2nd priority, do if you want to be a REAL Sweetie, make a separate pile for those items.
- 3. Stuff them into plastic baggies and label.

Only "Manufacturer's Coupons" can be used. They can be from the newspaper, dispensers in grocery stores, tear-pads, and elsewhere as long as they state "Manufacturer's Coupon" on them. No assistance vouchers. No food stamps. No store coupons. No restaurant coupons. No Internet coupons.

# CCA LOUISIANA, SHELL OIL BUILD BIG JACK'S REEF IN CALCASIEU LAKE

On Wednesday, Coastal Conservation Association Louisiana, along with Shell Oil, Building Conservation Trust (CCA's National Habitat Program), the Louisiana Department of Wildlife and Fisheries (LDWF), Lotte Corp, Road Rock Recycling and DLS Energy hosted government officials, volunteers and media members to view the installation of Big Jack's Reef in the southeast portion of Calcasieu Lake.

The reef is named in honor of the late Jack Lawton, Sr., known by family and friends as "Big Jack." Mr. Lawton, a renowned businessman and beloved philanthropist from the Lake Charles area, was a founding member of CCA Louisiana and the Lake Charles CCA Chapter. Members of the Lawton family were on hand to view the construction.

"My dad loved to fish and he loved Big Lake and did whatever he could to ensure it would be a great place to fish for everyone," said Jack Lawton, Jr. during the dedication ceremony. "We are honored and thankful that the Lake Charles CCA chapter chose to recognize him in this way. He would be very proud of this project."

Construction began last week on the five-acre reef, which is comprised of recycled whole and crushed concrete. The reef will consist of about 800 recycled concrete pilings that are being placed in a parallel arrangement across the 5-acre site. It will then be topped with crushed concrete to provide a more aggregated surface. The reef construction should be completed by mid-June.

"This reef will provide excellent habitat for trout, reds and other marine species," said CCA Louisiana VP of Habitat John Walther. "The parallel arrangement of the concrete pilings will help capture the tidal flow across the reef and create eddies where baitfish will be found. I expect before long, Big Lake anglers will be catching nice specks on Big Jack's Reef."

Big Jack's Reef is the 20th reef of its kind to be built by CCA Louisiana since 2002. This new reef will be the third of its kind built by CCA in Calcasieu Lake in recent years. In 2007, "Turner's Bay Reef" was constructed. In 2012, CCA and their partners installed the "Brad Vincent Reef" in mid-Calcasieu Lake. Both projects have proven to provide exceptional fish habitat, and are popular amongst recreational anglers.

CCA Louisiana Chairman Bob Bush was on hand for the visit and reflected on the importance of projects like this one.

"I have been fishing Big Lake for years, and I have seen us lose an incredible amount of reef habitat," said Bush. "I am proud of CCA, our local chapter, and our partners for stepping up to create this new habitat in an area where the reefs have been so badly diminished. We are committed to doing more and more projects like this one in the future."

Walther acknowledged project partners at LDWF, Shell, the Building Conservation Trust, Lotte Corp, Road Rock Recycling and DLS, all of whom were on-hand for the site visit.

"This is a great partnership between a conservation organization like CCA, a state agency like Wildlife and Fisheries and multiple corporate partners who came together to create fisheries habitat that will endure for generations," said Walther. "We could not have done this without each and every one of our partners."

Funding for the project was provided through CCA's Building Conservation Trust, Shell, LDWF's Artificial Reef Development Fund, as well as in-kind donations and services from the other project partners. Continued support of CCA's habitat program is provided by the Paul Candies Family. Upon completion, marker buoys will be placed on the site so that anglers can locate the reefs. Exact GPS coordinates will be made available at ccalouisiana.com upon project completion.



# LSU STUDY: GULF COAST OIL AND NATURAL GAS TO REBOUND

The Louisiana oil industry is expected to rebound in the coming years and natural gas will continue driving billions in investment in the state, according to an LSU study released today.

But because the recent downturn in the oil industry was so severe and prices are not forecast to be as high as they have been in past years, the sector is only projected to recover half of the jobs recently lost by 2020. Oil prices are forecast from \$51 to \$59 per barrel in 2017 and \$55 to \$75 per barrel by 2018.

Overall, the Gulf Coast Energy Outlook, an LSU study sponsored by Regions Bank, paints a tentatively rosy picture for the oil and gas industries for the coming decade, assuming prices remain within the forecast range.

Cheap, abundant natural gas has been a boon for the Gulf Coast chemical industry, and that trend appears poised to continue, researchers say. Natural gas serves as a key component in chemical manufacturing, and companies have planned or completed billions in capital projects in recent years.

For Louisiana, 2017 is forecast as the peak year for capital spending by energy manufacturing companies, with more than \$25 billion projects announced or completed for the year. Most of that spending—more than \$15 billion—comes from LNG export projects.

All told, \$96 billion in uncompleted capital projects are planned for Louisiana.

The LSU researchers forecast a steeper climb in employment for Louisiana's upstream oil and gas industries compared to Texas, which has a much larger industry. The same is true for Louisiana's refining and chemical manufacturing sector.

Gulf Coast energy production will soar in the coming decade, the researchers predict, as will production throughout the U.S. In recent years, surging U.S. production—fueled in large part by technological advances in shale drilling—has helped cause a downturn in oil prices. OPEC cut a deal late last year to cut output in an attempt to artificially inflate prices, and the U.S. benchmark oil price currently sits at around \$43 per barrel.

Louisiana's oil sector has taken a hit from the recent downturn, shedding thousands of jobs and helping drive a state recession. The price decrease—from more than \$100 per barrel to around \$30 per barrel—also hurt the state budget. Roughly speaking, a one dollar decrease in oil prices sustained over a year is a \$12 million hit to state revenues.

# Joules of wisdom (source: energy.gov)

What could you be doing differently this summer to conserve energy and save money?

- 1. Programmable thermostats can save up to \$150 a year on energy costs when used properly. Use one that can automatically turn off your cooling system when you are not home, and turn your system on in time for you to arrive home to a cooled house.
- Leaving a computer on all day can cost about 21 cents per day, or about \$75 per year. Unplug
  electronics and appliances when not in use a task made easier by using multiple-outlet strips,
  which can turn everything off with the flip of a switch.
- 3. By using the microwave, toaster or a counter-top grill rather than an oven, you'll use less energy and avoid excess heat that increases room temperature.
- 4. Heating water can account for 14 to 25 percent of the energy consumed in your home. Turn down the temperature of your water heater to the warm setting (120°F) and save energy (and avoid a surprise faucet-scalding).
- If you use air conditioning, a ceiling fan will allow you to raise the thermostat setting about 4°F with no reduction in comfort. Just make sure to turn it off when you leave the room (fans cool people, not rooms).
- On average, households lose about 20 percent of their heated and cooled air through the duct system to the outside. To avoid wasting energy, have your ducts inspected to ensure they're sealed properly and insulated if necessary.
- 7. Well-planned landscaping isn't just for aesthetics -- properly placed trees around the house can save between \$100 and \$250 annually.
- 8. Running your air conditioning at 78°F instead of 72°F can save between 6 and 18 percent on your cooling bill. The smaller the difference between the indoor and outdoor temperatures, the lower your overall cooling bill will be, so set your thermostat as high as possible during the summer months.
- 9. If #8 isn't enough reason to make the switch to CFLs, only about 10 to 15 percent of the electricity that incandescent lights consume results in light -- the rest is turned into heat.
- 10. Lighting makes up about 10 percent of home energy costs. Save up to 75 percent of that energy by replacing incandescent bulbs with compact fluorescent bulbs (CFLs). They also last longer, saving money on replacements.
- 11. Placing lamps or TV sets near your room air-conditioning thermostat can cause the air conditioner to run longer than necessary because the thermostat senses heat from the appliances. Set them apart and save energy.

#### **Reduce Electricity Usage and Costs**

In our homes, we rely on electricity to power our lights, appliances, and electronics. Many of us also use electricity to provide our homes with hot water, heat, and air conditioning. As we use more electricity in our homes, our electric bills rise.

Here are a few ways to reduce your electricity use and maybe save money on your electric bills:

- Choose efficient appliances and use them wisely to save money and energy. You can save
  money and energy at home by choosing energy efficient appliances and electronics and reducing
  the amount you use them.
- Use an advanced power strip to reduce "vampire loads"--electricity that is wasted when electronics are not in use.
- Light your home using the *same amount of light for less money*. An average household dedicates about 5% of its energy budget to lighting. Switching to energy-efficient lighting is one of the fastest ways to cut your energy bills. By replacing your home's five most frequently used light fixtures or bulbs with models that have earned the ENERGY STAR, you can save \$75 each year.
- New lighting standards took effect in 2012, and many money-saving options such as halogen incandescent, CFL, and LED light bulbs are available today. For high-quality products with the greatest energy savings, choose bulbs that have earned the ENERGY STAR.
