

When something's expired you have to get rid of it, right? Not when it comes to coupons. Did you know?

Expired coupons work.

Save them whether they're active or expired (Not expired more than 3 months). Coupons can be used on overseas military bases for up to six months past their expiration date.

Military families benefit.


Many military families rely on donated coupons to help offset the expense of living overseas.

#### -- Bagging Instructions --

- Cut out the coupons.
- Sort coupons into two piles by status:
- a. Expired. Not expired more than 2 months. (e.g. if today's date is 3/1/2018, you would cut out coupons with an expiration date that is not older than 1/1/2018).
  - b. Unexpired. At least two months of life left.
- Sort each of those two piles into four piles by type:
  - a. Food items
  - b. Non-food items
  - c. Baby food/items
  - d. Pet items (like dog food)
- Stuff them into plastic baggies.
- Write the status (Expired or Unexpired) and the type (food, non-food, baby, or pet) on them.
- Total the retail savings of the baggies and write it on them. This helps us track the value of the overall program.

Only "Manufacturer's Coupons" can be used. They can be from the newspaper, dispensers in grocery stores, tear-pads, and elsewhere as long as they state "Manufacturer's Coupon" on them. No assistance vouchers. No food stamps. No store coupons. No restaurant coupons. No Internet coupons.

Thank you for making a difference in the lives of our military troops and their families!

A special Ad Hoc committee and the 2018 board has taken steps for 2019, with the following changes to committees. Special committees will be ADDC Manual Review, Contest, Strategic Planning Committee (Long Range, Leadership, GAME), Nominating and Technology. The proposed changes to the Standing Committees require an amendment to the Association Bylaws. SUBJECT: Amendments to ADDC Bylaws and Standing Rules

#### On behalf of the 2018 Rules Committee:

Amendments to the ADDC Bylaws and Standing Rules were voted on at the 2018 ADDC Convention. The revised amendments are listed below, as they were approved with any amendments to the proposed amendments. The ADDC Bylaws and Standing Rules will be updated and posted in their entirety on the ADDC website in January 2019.

#### **BYLAWS**

#### Article III - Structure Section 2.

(a) The Central Region shall consist of the states of Kansas, Iowa, Minnesota, Missouri, Nebraska, North Dakota, Oklahoma, South Dakota and the northeastern portion of the state of Texas bounded on the north by the northerly boundary lines of the counties of Bowie, Clay, Cooke, Fannin, Grayson, Lamar, Montague, Red River, and Wichita; on the east by the easterly boundary lines of the counties of Bowie, Cass, Harrison, Marion, Panola, Sabine, and Shelby; on the south by the southerly boundary lines of the counties of Anderson, Cherokee, Coryell, Freestone, Limestone, McLennan, Nacogdoches, Sabine, and San Augustine, and on the west by the westerly boundary lines of the counties of Archer, Bosque, Coryell, Erath, Palo Pinto, Wichita and Young and the provinces of Manitoba and Saskatchewan in Canada.

(b) The Northeast Region shall consist of the District of Columbia, the states of Connecticut, Delaware, Illinois, Indiana, Kentucky, Maine, Maryland, Massachusetts, Michigan, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont, Virginia, West Virginia and Wisconsin within the United States and the provinces of New Brunswick, Newfoundland, Nova Scotia, Ontario, Prince Edward Island and Quebec of Canada.

(c) The Southeast Region shall consist of the states of Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, and the southeast portion of the state of Texas bounded on the north by the northerly boundary lines of the counties of Angelina, Bell, Bexar, Comal, Falls, Hays, Houston, Jasper, Kinney, Leon, Medina, Newton, Robertson, Travis, Uvalde, Williamson; on the east by the easterly boundary lines of the counties of Newton, Orange, and Jefferson; on the south by the southerly boundary lines of the counties of Aransas, Brazoria, Calhoun, Cameron, Chambers, Galveston, Harris, Jefferson, Kenedy, Kleberg, Matagorda, Nueces, Refugio, San Patricio and Willacy; on the west by the westerly boundary lines of the counties of Cameron, Dimmit, Hidalgo, Kinney, Maverick, Starr, Webb and Zapata.

(d) The West Region shall consist of the states of Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, New Mexico, Nevada, Oregon, Utah, Washington, Wyoming, and the western portion of the state of Texas bounded on the east by the westerly boundaries of the counties in the Central Region, and the northerly boundaries in the Southeast Region and the provinces of Alberta and British Columbia in Canada.

#### Article III - Structure Section 7.

The ADDC is not formed for pecuniary gain or profit and does not contemplate pecuniary gain or profit to members or officers thereof, and no part of the net earnings of the Association shall inure to the benefit of any member or officer thereof, or to any private individual.

#### Article IX - Nominations and Election of Officers Section 1.

Nominees for any Association office shall be employed in or retired from the petroleum, energy, or allied industries. Nominees for regional director shall have served or be serving as a President of a Desk and Derrick Club. Nominees for all other offices shall have served or be serving as a regional director. All nominees shall be bondable.

#### ARTICLE X - DUTIES OF OFFICERS SECTION 4.

The Treasurer shall supervise the collection and disbursements of all funds of the Association as directed by the Association Board of Directors; shall furnish the Board of Directors with a quarterly statement of income and expenditures; shall submit the Association books for review by an independent certified public accounting firm and the ADDC Finance Review Committee at the close of each fiscal year or more frequently as directed by the Board of Directors; and shall submit a written quarterly report with highlights (budget to actual variances and significant expenditures) of both ADDC operating funds and ADDC convention funds to the clubs. The Treasurer shall furnish a surety bond in an amount fixed by the Board of Directors, the cost of which shall be borne by the Association. The Treasurer shall prepare a budget at the beginning of the year to be submitted to the Board of Directors for their consideration and shall perform such other duties as may be required of the office.

#### ARTICLE XI - BOARD OF DIRECTORS SECTION 2

(d) Board members may meet by videoconference or teleconference. This meeting shall be conducted by a technology that allows for simultaneous aural communication among all participating members equivalent to those of a meeting held in one room or area in that all participating members hear each other, as well as see each other (if videoconference), at the same time. Board members who are unable to attend a board meeting due to unavoidable circumstance may join the meeting by teleconference or videoconference.

#### ARTICLE XIV - CONVENTIONS SECTION 1

(e) The Board of Directors shall approve the registration fee, a detailed budget, and authorize convention expenditures.

#### **STANDING RULES**

11.

c. Should the balance in the Convention Fund exceed \$20,000, the Association Board may transfer, as the need arises, no more than \$10,000 in any one year to the General Fund. Up to \$5,000 additional funds may be transferred to meet legal obligations. The transfer of funds shall be communicated to clubs within thirty (30) days.

## Report: Excessive civil tort costs taking a toll on Louisiana economy

Excessive civil court costs in Louisiana are having a direct, negative effect on the state's economy, according to a new report released today by Louisiana Lawsuit Abuse Watch, a grassroots organization that advocates for tort reform.

The 2018 Economic Benefits of Tort Reform study found that frivolous lawsuits and excessive damage awards are costing the state's economy some \$1.1 billion a year and more than 15,500 jobs. The study asserts that all major industry groups in the state are negatively impacted by the legal climate, with retail trade, business services, health services and other service industries showing a direct loss.

The study also claims that state government loses some \$76.4 million a year in revenues, while local governments lose some \$64.3 million a year as a result of excessive legal costs.

"These findings clearly show that civil justice reform must be a priority in Louisiana," says Lana Venable, executive director of Louisiana Lawsuit Abuse Watch. "Frivolous lawsuits and exorbitant plaintiff awards impact all sectors of our economy and hurt Louisiana families, as costs are ultimately passed down to them in the form of higher prices for goods and services."

The study was conducted by The Perryman Group for Citizens Against Lawsuit Abuse, a national organization with which Louisiana Lawsuit Abuse Watch is affiliated. The study compared Louisiana's civil court systems and related costs with those of Ohio, which has enacted significant tort reform measures in recent years.

Tort reform measures invariably top the legislative agenda for state and local business groups every year in Louisiana, and while some reforms have been enacted in recent years, Louisiana continues to rank poorly when compared to other states.

Louisiana's legal climate was ranked 50th in 2017 by the U.S. Chamber Institute for Legal Reform and was among the top 10 states listed as "judicial hellholes" in 2017 by the American Tort Reform Foundation.

"We've had some small improvements," Venable says. "But this underscores that we still have a long way to go."
