

Who's Going to Take Care of You When You Get Old?

Paying for Long Term Care

Is it covered by Medicare and health insurance? **NO (not typically)** - unless on hospice or short-term home health order (aide for bathing)

Possible sources:

- Long-term care insurance
- Veteran Aid & Attendance pension supplement
- Personal savings
- Bridge loan for sale of home
- In Louisiana, neither independent living, assisted living, or memory care are covered by Medicaid
- Medicaid (LT-PCS and waiver program for in-home)

Typical Costs

- In-home care: \$20/hr
- Independent Living: \$ 2700
- Assisted Living: \$4000 (max LOC, but smallest room)
- Residential Assisted Living (personal care home): \$ 4300
- Memory Care: \$5000
- Nursing (custodial): \$1000 to 1800 above assisted living

Note - these are average monthly costs, and there is quite a range

Desk and Derrick Club of the Westbank College Scholarship Guidelines

General Guidelines for All Applicants:

- Must submit application through an active Westbank Desk and Derrick member. All
 active Westbank Club Members are encouraged to apply for the Scholarship, provided
 they meet the guidelines.
- Graduating High School Seniors must provide copies of <u>both</u> GPA and ACT scores.
 Proof of <u>cumulative</u> GPA with a minimum of 2.75 and ACT of 23 is needed to qualify.
 These scores must be on an <u>official transcript with student name</u>.
- All High School Seniors must provide a Letter of Acceptance from the College or University attending.
- Current college students must submit proof of <u>cumulative</u> GPA of 2.75 or higher on an <u>official transcript with student name</u>.
- All applicants must submit completed application form, including all requested documentation to your Desk and Derrick Sponsor by March 15th.
- No applicant will be granted more than four annual Scholarship Awards (need not be four consecutive years).
- All applicants must provide at least one letter of recommendation in addition to your Desk and Derrick Sponsor or immediate family member.
- All applicants must provide a letter or essay detailing intended field or study and educational goals.

Desk and Derrick Sponsor Responsibilities:

The Desk and Derrick Sponsor must write and submit a letter to the committee detailing their personal knowledge of the applicant. This letter, the application, and all attachments, **MUST** be submitted to the Scholarship Chairman or be postmarked by March 15th and mailed to: Desk and Derrick Club of the Westbank Scholarship Chairman, P. O. Box 2875, Gretna, La. 70053-2875. Incomplete applications or those received after the deadline will be disqualified.

Scholarship awards will be issued from available funds no later than June 30th of each year. Scholarship checks will be issued jointly to the scholarship recipient and the appropriate College/University. Scholarship checks must be cashed within the 180-day time period as per banking regulations, or the funds will be forfeited.

Coupons for Troops

When something's expired you have to get rid of it, right? Not when it comes to coupons. Did you know?

Expired coupons work.

Save them whether they're active or expired (Not expired more than 3 months). Coupons can be used on overseas military bases for up to six months past their expiration date.

Military families benefit.

Many military families rely on donated coupons to help offset the expense of living overseas.

-- Bagging Instructions --

- Cut out the coupons.
- Sort coupons into two piles by status:
- a. Expired. Not expired more than 2 months. (e.g. if today's date is 3/1/2018, you would cut out coupons with an expiration date that is not older than 1/1/2018).
 - b. Unexpired. At least two months of life left.
- Sort each of those two piles into four piles by type:
 - a. Food items
 - b. Non-food items
 - c. Baby food/items
 - d. Pet items (like dog food)
- Stuff them into plastic baggies.
- Write the status (Expired or Unexpired) and the type (food, non-food, baby, or pet) on them.
- Total the retail savings of the baggies and write it on them. This helps us track the value of the overall program.

Only "Manufacturer's Coupons" can be used. They can be from the newspaper, dispensers in grocery stores, tear-pads, and elsewhere as long as they state "Manufacturer's Coupon" on them. No assistance vouchers. No food stamps. No store coupons. No restaurant coupons. No Internet coupons.

Thank you for making a difference in the lives of our military troops and their families!

Shell Begins Production At Alpha Olephins Unit In Geismar As Part Of \$717 Million Project

Shell Chemical LP has started production on the fourth alpha olefins unit at its Geismar manufacturing plant, the company said Monday.

The \$717 million project was announced in 2015, and brings total alpha olefins production up by more than 468,000 tons per year to more than 1.4 million tons. Shell broke ground on the project nearly three years ago.

"Our team delivered this world-class expansion project safely, on time and within budget," Grant van't Hoff, executive vice president for Shell's global chemicals business, said in a statement.

Alpha olefins are ingredients in products including laundry detergents, motor oils and hand soaps.

Shell built several new pieces of infrastructure as part of the expansion, including a new water cooling tower, a significant expansion of the site's rail loading capabilities and repurposing a previously idled tank farm.

The project created 2,000 construction jobs and 20 permanent jobs, Shell said.
