

ACE Pipeline—Speaker Tristan Babin

Our January speaker, Tristan Babin, has a very impressive resume. He is currently the Communications and Public Affairs Advisor at the Phillips 66 Alliance refinery. Tristan represents the company in community, charitable contributions, local government and media, and with internal communications. His passion for digital communications brought about an internal app and video channel for employees. His education includes and B.A. in Mass Communication with a double major in Broadcast Journalism and Spanish/Hispanic studies from the Univer- __sity of Louisiana at

Journalism and Spanish/Hispanic studies from the Univer-Lafayette. He also has an MBA, with focus on Marketing, from UNO. He recently became engaged and used his love of Game of Thrones for the theme of the surprise engagement party when he popped the question (She said YES!).

Tristan shared information on the upcoming ACE (Alliance Chalmette Extension) Pipeline. The project is a partnership with Harvest Midstream, Phillips 66, and PBF. They are jointly working on a new pipeline to transport crude oil from the market hub in St. James Parish to existing refin-

ACE Pipeline

The ACE pipeline system will transport crude oil from the market hub in St. James Parish to downstream refining destinations in Belle Chasse, Meraux and Chalmette, Louisiana.

ing operations in Belle Chasse, Meraux, and Chalmette. The main goal for the pipeline is providing safe, reliable transportation of crude oil in the region. This will improve Louisiana refineries' access to growing energy resources in the United States and boost the global competitiveness of the energy industry in our state.

The pipeline increases the ability of Phillips 66 in Belle Chasse to buy domestic crude and reduces need for supplies from ships on the Mississippi River. Plus, the pipeline would benefit other refining destinations that aren't connected to the St. James Hub..

Tristan ensured us that Phillips and the pipeline partners are committed to being a good neighbors. At each stage of the pipeline planning process, they have openly shared the plans for ACE and have sought input from local and state elected officials. .

The project is currently going through permitting at the state and federal levels before moving to the local level. At this point we anticipate to begin construction in late 2020 and to have the pipeline in service in the first half of 2021.

Following a few questions, President Angie Duplessis presented Tristan with a certificate of appreciation and a note informing him that the club is making a donation to our Scholarship Fund in his honor.

ACE PIRELINE


The ACE pipeline system will transport crude oil from St. James, Louisiana, to refining centers in Belle Chasse, Meraux and Chalmette, Louisiana. The pipeline will be a joint-venture between Phillips 66 Partners, Harvest Midstream and PBF Logistics. Phillips 66 will construct the new-build segment of the pipeline system. Harvest Midstream will operate the system when completed.

ACE Pipeline will include a 58-mile new-build segment to connect the St. James market center to Harvest Midstream's existing CAM Pipeline and the major refineries it serves. The pipeline is expected to be in service in the second half of 2020.

 Department of Wildlife, the pipeline route was
 chosen based on the least environmental
 Impact and least acres of wetlands crossed.







Over the past few years, many ADDC clubs have become smaller. Some challenges we are all facing include:

- ♦ Your club meeting this month is on the 22nd, the speaker you booked 3 months ago just cancelled. It's getting toward the end of the year, and you still need an educational program.
- ♦ You have a small but mighty club 6-20 members. Securing a speaker is next to impossible. You've used every video available to you. You want to keep the group interested, but don't know where to turn. What can you do?
- Are bylaws and procedures more a hindrance than a help to your members?
- ♦ For the last year your club has covered the stages of a well from Seismic readings to marketing the finished product. You're now planning the meeting line-up for the next year. Covering the stages of a well will cause members to run away screaming. What new ideas can you present? Where do you turn to find new ideas?



OFFSHORE GULF OF MEXICO SHELF AND DEEPWATER ACTIVITIES

During January 2020, the U.S. Department of the Interior Bureau of Safety and Environmental Enforcement (BSEE) approved 82 Gulf of Mexico (GoM) drilling permits. Eighteen of these were for shelf wells, and 64 were for deepwater wells. Of the total number of permits, there was 1 new well permit, and it was issued in deepwater.

The single deepwater new well permit was for an exploration well. Beacon Growthco Operating Company received the new well permit for their Green Canyon 821 #2 well.

On January 31st, the GoM mobile offshore rig supply stood at 69, which is 2 less than last month. The marketed rig supply consisted of 40 rigs, of which 31 were under contract. The marketed rig supply and the contracted rig supply numbers are also both 2 less than last month. The marketed contracted versus total rig supply utilization rate stood at 44.9%, and the marketed contracted versus marketed supply utilization rate stood at 77.5%. By comparison, the January 2019 total fleet utilization rate stood at 44.4% with 32 rigs under contract out of the 72 rigs in the fleet.

As of January 31st, there are 21 active mobile offshore rigs in the GoM, which is 67.7% of the rigs under contract mentioned above. This active rigs number is 2 less than reported last month. Currently, there are 2 rigs drilling on the shelf and 19 in deepwater. In December of last year, there were 19 mobile offshore rigs operating in the GoM representing a 10.5% increase in active rigs year over year.

As of January 31st, the total U.S. rig count stood at 790 rigs, which are 15 fewer rigs than reported at the end of December 2019. Of the 790 rigs, 675 (85.4%) are oil rigs and 112 (14.2%) are gas rigs. A year ago, there were 1045 rigs working in the U.S. Thus, the current rig figure represents a 24.4% decrease in rigs year over year. Texas continues to have the largest number of rigs presently with 395, which is exactly half (50%) of the total number of rigs in the U.S. Louisiana has a total of 52 rigs, down 6 rigs from last month. Nationwide, Louisiana ranks fourth in the rotary rig count; New Mexico ranks second with 108 rigs, and Oklahoma ranks third with 53 rigs.

Chocolate Icebox Pie

1 pre-made graham cracker crust, 1 cup sugar, 1/2 cup cocoa powder, 2 Tbsp flour, 2 eggs 1 12 oz can evaporated milk, 2 tsp butter, 2 tsp vanilla, 1/4 tsp salt

1 can whipped cream

1 bar milk chocolate

Whisk together sugar, cocoa powder, flour, eggs, evaporated milk, butter, vanilla and salt in a sauce pan. Gently heat the mixture to boiling, stirring frequently to ensure that you do not scald the mixture. Allow mixture to boil for 1 minute until it is thick and smooth. Pour mixture into the pie crust and allow to cool for at least 30 minutes and then place the pie in the refrigerator. Once pie is cool add whipped cream to the top. You can get creative with this or you simply spray it on the pie and spread it around. Sprinkle crushed chocolate bar on top of whipped cream and serve!
