The residents of the St. Joseph Apartments will appreciate it.







#### **Proposed Amendments in Summary – 2021 Rules Committee**

#### Proposed Bylaws Amendment 1 – Article XII Section 1

Submitted by the Club Bylaws/Guidelines Review Committee: Separate the committee back to two; it's a heavy workload and committee requires chairman/co-chairman.

Amend to Read: The Standing Committees of the Association shall be the following: <u>Club Bylaws Review</u>, Education/Certification, Finance Review, <u>Guidelines Review</u>, Membership, Program, Public Relations, Rules, and Tax Exempt. Special committees may be created from time to time as deemed necessary by the Board of Directors.

#### Proposed Bylaws Amendment 2 – Article XIV Conventions Section 2

Submitted by Rules Committee: insert "a majority" for consistent voting requirements.

Amend to Read: In the event of an extreme emergency, the Board of Directors may suspend the holding of a convention, but a second convention may be suspended only by a majority vote of the clubs.

#### Proposed Bylaws Amendment 3 – Article XV Regional Structure

Submitted by ADDC Board and Rules Committee: add a section regarding suspending or holding virtual regional meeting.

Amend to Read: A regional meeting may be suspended or held virtually by a majority vote of the clubs in that region. Participation in a meeting pursuant to this provision constitutes presence in person at such meeting.

#### Proposed Bylaws Amendment 4 – Article XV Regional Structure

Proposed by Rules Committee: add a section giving options for email, mail, and fax voting.

Amend to Read: The regional director and delegates may transact business by email, mail, or facsimile transmission (fax). An affirmative vote must be cast by a majority of the delegates to constitute action of the voting body unless the item being voted on requires a two-thirds (2/3) vote. The vote shall be ratified at the next regional meeting.

#### Proposed Standing Rules Amendment 1 – Rule Number 5

Proposed by ADDC Board: change "shall" to "may" – based on definitions of the words. Gives ADDC President option of having a scrapbook.

Amend to Read: Each year a scrapbook <u>may</u> be compiled and presented to the President of the Association. Scrapbooks and other Desk and Derrick memorabilia may be donated at any time to the Scrapbook committee or to the Association Distribution Office to compile a history of the Association.

#### Proposed Standing Rules Amendment 2 - Rule Number 6

Proposed by Rules Committee: Reword 2<sup>nd</sup> sentence to clarify process to submit requests for approval through regional director

Amend to read: Use of the Association logo or insignia in advertising is encouraged and supported. When a Desk and Derrick ad is to be included in any publication or media other than a club bulletin, the club shall submit a request through the regional director for approval by the Immediate Past President. This will ensure that the logo or insignia is used appropriately.

#### Proposed Standing Rules Amendment 3 – Rule Number 7

Proposed by ADDC Board: Replace first sentence to change approval process to Immediate Past President.

Amend to Read: A club desiring to use any social media shall submit ADDC Form 51 SM to the regional director for approval by the Immediate Past President. The club must adhere to the guidelines as set out in the Club General Information Section, Article VII, Social Media Guidelines. Any violation of the guidelines will be referred to the Board and shall result in a written request to terminate the site. The club will be considered a "club not in good standing" until the site has been terminated.

#### Proposed Standing Rules Amendment 4 – Rule Number 9, Paragraph b.

Proposed by Rules Committee: Replace existing paragraph and replace to clarify process to submit approval requests through regional director.

Amend to Read: <u>Clubs shall submit requests through the regional director for any club sales item</u> and accompanying printed materials bearing the words "Desk and Derrick," "D&D," "Association of <u>Desk and Derrick Clubs,</u>" "ADDC," and/or the trademark (insignia) for approval by the Immediate Past President.

#### Proposed Standing Rules Amendment 5 – Rule Number 9, Paragraph c. 2)

Submitted by ADDC Board and Rules Committee: Replace to clarify approval process through the regional director and change approval from ADDC Board to Immediate Past President.

Amend to Read: <u>Clubs interested in selling any items outside of their home region must submit requests through the regional director for approval by the Immediate Past President.</u>

#### Proposed Standing Rules Amendment 6 – Rule Number 10, Paragraph b.

Submitted by Rules Committee: change to provide consistent wording for approval through regional director.

Amend to Read: <u>Clubs shall submit requests through the regional director for any such item (see 10 a.) and accompanying printed materials bearing the words "Desk and Derrick", "D&D", "Association of Desk and Derrick Clubs", "ADDC", and/or the trademark (insignia) for approval by the Immediate Past President.</u>

#### Proposed Standing Rules Amendment 7 - Rule Number 12

Submitted by ADDC Board: replace with statement clarifying ADO attendance at convention and board meetings


Amend to Read: At the discretion of the Board of Directors, a member of the Association Distribution Office may attend the annual convention and/or Association Board Meetings without voice or vote. If the financial status of the Operating Fund allows, approved expenses may be paid by the Association.

#### LOUISIANA STATE PROFILE AND ENERGY ESTMATES

#### **QUICK FACTS (SOURCE EIA.GOV)**

- Louisiana is one of the top five states in both natural gas production and proved reserves. The state accounted for 9% of U.S. total marketed gas production in 2020 and has about 8% of the nation's gas reserves.
- Louisiana's 17 oil refineries account for nearly one-fifth of the nation's refining capacity and can process about 3.4 million barrels of crude oil per day.
- In 2020, Louisiana's two liquefied natural gas (LNG) export terminals shipped out about 55% of U.S. total LNG exports.
- Louisiana's total energy consumption and per capita energy consumption both rank among the top three states in the nation, largely because of its energy-intensive chemical, petroleum, and natural gas industries.
- Louisiana has the highest per capita residential sector electricity consumption in the nation. More than 6 in 10 Louisiana households rely on electric heating and almost all households have air conditioning.

#### Louisiana History—Oil Industry

#### 1909: A Year of Big Discoveries

The year 1909 was a special year for the oil and natural gas industries in Louisiana. The first oil refinery built near Baton Rouge went on line. This site was located where the Exxon refinery exists today. Presently, the Exxon site is one of the largest oil refineries in North America.

Also in 1909, a new type of drilling bit known as the Hughes rotary drilling bit was developed. This bit not only made drilling more efficient, it allowed <u>paleontologists</u> to collect and analyze the rock for <u>microfossils</u>. These <u>microfossils</u> could serve as important index fossils for particular deposits perhaps denoting the presence of oil deposits.

And finally in 1909, construction of Louisiana's first long-distance oil pipeline was begun and by 1910 served to transport crude oil from Caddo Parish to the Baton Rouge refinery.



## Cool and Crunchy Chicken Lettuce Wraps

#### Ingredients

Vegetable or canola oil, for grill grates

¼ cup fresh lime juice (from 3 limes)

1/4 cup fish sauce

3 cloves garlic, grated (2 tsp.)

2 tablespoons sambal oelek (ground fresh chili paste) or sriracha

1 tablespoon granulated sugar

2 pounds boneless, skinless chicken thighs

4 ounces rice vermicelli noodles (from an 8.8-oz. pkg.)

1 head green leaf lettuce or butter lettuce, leaves separated

shaved rainbow carrots and cucumber matchsticks, for serving

#### Directions

#### Step 1

Preheat grill or a grill pan to medium-high (450°F to 500°F) and lightly oil grates. Bring a large pot of water to a boil on stove.

#### Step 2

Whisk lime juice, fish sauce, garlic, sambal oelek, sugar, and ¼ cup water in a small bowl until sugar dissolves. Transfer ½ cup sauce to a medium bowl; reserve remaining sauce for serving. Add chicken to medium bowl and stir to coat. Let stand for 5 minutes.

#### Step 3

Meanwhile, cook noodles according to package directions. Drain and rinse under cold water; set aside.

#### Step 4

Place marinated chicken on grill grates; discard marinade. Grill chicken, covered, turning occasionally, until lightly charred and cooked through, about 8 minutes. Transfer to a cutting board and chop into bite-size pieces. Serve chicken with lettuce leaves, noodles, reserved sauce for dipping, carrots, and cucumber.
