
Gaylen Guillory won \$53 with 50:50 drawing.

#### Scholarship Guidelines

### General Guidelines for All Applicants:

- All applications shall be submitted through a Sponsor; sponsor must be an active Westbank Desk and Derrick Club member in good standing.
- All applicants must submit completed, appropriate (High School or College) application form and all required documentation to Sponsor by March 1<sup>st</sup>.
- All applicants must provide a letter or essay detailing intended field of study and educational and personal goals. Include information on any extracurricular activities, such as community service, clubs, hobbies, employment, etc.
- All applicants must provide at least one (1) letter of recommendation from a school official, career counsellor, teacher, or professor on school or business letterhead.

### Graduating High School Seniors:

- Must provide copies of <u>both</u> GPA (minimum 2.75) and ACT scores (minimum 23) or equivalent SAT scores.
  - Scores must be provided on official documents (transcript and official test results) with student name.
- 2. Must provide a Letter of Acceptance from the college or university attending.

#### Current College Students:

- Must provide proof of <u>cumulative</u> GPA (minimum 2.75).
  - a. Score must be provided on official school transcript with student name.

## Incomplete applications or those received after the March 1st deadline will be disqualified.

Scholarship checks will be issued jointly to the scholarship recipient and the appropriate College/University. Scholarship checks must be cashed within the 180-day time period per banking regulations or the funds will be forfeited.

Merry Christmas, Happy Hanukkah, or Happy Kwanza to you and your family in celebrating the holidays! I hope everyone has a safe and wonderful season that we reflect on the past and look toward the future.

This year was busy for the 2023 ADDC Board and we voted on 50 items of business this year. The 2024 ADDC Board is ready to hit the ground running and I know they will do an excellent job leading our Association. Our goal is to continue to support our industry and educate our members as well as educate the general public about the oil and gas industry. We strive to gain new members and retain our current members. Together, we can ensure ADDC is a viable, sustainable, and resilient organization.

In the November ADDC Board meeting, the motion passed to revise the Bylaws-Article IV – Educational Program Requirements. This will be effective January 1, 2024. The addition of:

Item F. A Club that has not met the program meeting requirements as described in Section A of this Article by the end of the calendar year shall be considered non-compliant and shall not be eligible to have a voting delegate or alternate at any Association meeting (Region or Convention) for the next calendar year.

The Board also updated the Board Procedures to keep in line with the way business is currently conducted, and also voted on updates to the Region Director training material. If you have been a club president, then you can be a Region Director! You will receive training from the ADDC President-Elect and a training manual to help you know what and when to perform your Region Director duties...you are not alone, and it is a great way to learn more about ADDC and your region! The ADDC Board voted to alter the dates concerning the AIMEEs. The AIMEE category submittals dates for 2023 will encompass January 1, 2023 through December 31, 2023. The deadline for AIMEE submittals will be 11:59PM, January 15, 2024, via electronic submittal. Please make note of these changes.

The 2022 FRC is completing their review of the 2022 ADDC Financials and hopefully will be sent to membership soon. The 2023 FRC is finishing up the 3<sup>rd</sup> quarter and will send out to membership this month, and the 4<sup>th</sup> quarter 2023 financials will be sent out by March 2024.

I would like to say "Thank You" to the 2023 ADDC Board for all their hard work, determination, and perseverance in making ADDC better than the year before. That is how we grow. I want to especially thank each member of our organization. ADDC would not be what it is today without each of you! Thank you for electing me to lead you and ADDC in 2023. ### Back in the G.A.M.E.?

It has been a while since we heard anything about G.A.M.E. (Guidance And Mentoring Empowerment) and some of the goals that have been set out to help our members, clubs, regions, and Association retain and grow our membership. Instead of growing over the past few years, we have continued to decline, losing members and gaining very few new members.

We have survived many changes over the past 70+ years: the energy and allied industries; the companies that for decades supported ADDC and its goals; and the interests and needs of our members and potential members. Change is good, when the change is FOR good. Five years ago, the ADDC realigned the regions, consolidating seven to four. This was a good thing, but it wasn't the fix we hoped for in 2018.

Right now, we need to focus on retaining our members. How do we retain those who have 5, 10, or 20 years of membership? (I don't think we have to worry about losing those, like me, with over 32 years. We're in it forever.)

No one has all the answers, but things that any club can try:

- Keep members active and involved.
  - Try to get every member serving on a committee, as a chairman or committee member.
  - Ask members to be speakers or to arrange for a speaker at a monthly meeting.
- Provide incentives (if funds are available) for members.
  - o Offer a free dinner once/year for Perfect Attendance
  - Subsidize all or part of annual dues
  - Reimburse a portion of Region Meeting or ADDC Convention registration
- Plan social activities that can include family and friends.

These are a few ideas that may help your club. Some clubs may already have great success in retention but are struggling to attract any new members. Maybe you can share some of your club's challenges and successes – or fails – with the 2024 ADDC Board or with Leadership Chairman Barbara Pappas. What worked for you may be something another club may also use successfully.

As we prepare to tackle the challenges in the new year, look at the positive aspects of the changes we face. Think back on the many changes we've survived since the beginning of ADDC in 1949. And think of how we can continue to change to meet the demands and needs of our current and future members.

The name of this initiative may be G.A.M.E. but this is not a game. This is real. Our future depends on being ready, willing, and able to adapt to the constant flux in our industries.

## **Recent Energy Headlines .....Recap of November 2023 News**

**11/2/2023 - Running low: US strategic oil reserve reaches lowest level in decades -** Over 200 million barrels of crude oil have been pulled out by President Joe Biden since the beginning of last year — around 40% of what was stored. There are always a lot of stories about the price of gasoline, how it impacts your wallet and how it may impact your holiday travel. But the truth is, the story about the price of gasoline is also about politics because high prices can impact elections and can hurt economies. Things like hurricanes, high temperatures, and production in the Middle East and U.S. Midwest are all factors that can impact the price of gas. <u>Read Full Article</u>

**11/3/2023 - Shell posts \$6.2 billion profit for third-quarter 2023 -** Shell plc had third-quarter 2023 adjusted earnings of \$6.2 billion, up from \$5.1 billion in second-quarter 2023, reflecting robust operational performance and higher oil prices and refining margins. However, the figure decreased year-over-year. Shell plc had third-quarter 2023 adjusted earnings of \$6.2 billion, up from \$5.1 billion in second-quarter 2023, reflecting robust operational performance and higher oil prices and refining margins. However, this figure represented a notable decrease from the \$9.45 billion reported one year earlier, when the Russia-Ukraine conflict boosted oil and gas prices. The company will implement a \$3.5-billion share buyback program for the next 3 months. <u>Read Full Article</u>

**11/14/2023 - IEA raises oil demand growth forecasts, flags possible 2024 surplus -** The International Energy Agency (IEA) on Tuesday raised its oil demand growth forecasts for this year and next despite slower economic growth in nearly all major economies, although its 2024 outlook remains much lower than that of producer group OPEC. The Paris-based IEA said the market could shift into surplus at the start of 2024 having been kept in a "significant deficit" through year-end by voluntary cuts from Saudi Arabia and Russia which last until the end of December. <u>Read Full Article</u>

11/15/2023 - Australia's Karoon Energy to buy stakes in LLOG's offshore assets for \$720 mln - Nov 16 (Reuters) - Karoon Energy (KAR.AX) announced deals worth \$720 million on Thursday to buy stakes in certain offshore oil and gas fields in the Gulf of Mexico from U.S.-based LLOG Exploration, in a move to diversify operations beyond Brazil and Australia. The oil and gas explorer said it would raise around A\$480 million (\$312.43 million) to fund a 30% stake purchase in the Who Dat and Dome Patrol fields in offshore Louisiana and a near 16% stake buy in the Abilene field. **11/16/2023 - Oil and Gas Lease Sale 261 Scheduled for Dec. 20, 2023 -** As a result of the order issued by the United States Court of Appeals for the Fifth Circuit on Nov. 14, 2023, the Bureau of Ocean Energy Management (BOEM) has scheduled Lease Sale 261 for Dec. 20, 2023. The Gulf of Mexico oil and gas lease sale was originally scheduled for Sept. 27, 2023, and later scheduled for Nov. 8, 2023, in response to judicial orders. Pursuant to direction from the Court, BOEM will include lease blocks that were previously excluded due to concerns regarding potential impacts to the Rice's whale population in the Gulf of Mexico. BOEM will also remove portions of a related stipulation meant to address those potential impacts from the lease terms for any leases that may result from Lease Sale 261. <u>Read Full Article</u>

Oil is the single most influential resource in modern history. It drives industrialization, it builds nations, and can decide the outcome of wars. It is responsible for raising millions of people out of poverty and for razing entire cities to the ground. Few, if any, industries have left as large a mark on Planet Earth, from technological advancements to environmental disasters.

The history of oil has been traced back as far as 3000 BC, when builders in Mesopotamia used bitumen to strengthen bricks. The story of the modern oil industry began in the 1850s. Since then, explorers, investors, kings, journalists, spies, and scientists have all attempted to leave their mark on the industry. These two women, for better or worse, are responsible for helping to shape the modern-day oil industry.

### WANDA JABLONSKI

In Daniel Yergin's *The Prize*, he refers to Wanda Jablonski as "the most influential oil journalist of her time." She founded Petroleum Intelligence Weekly, the journal which came to be known as "the bible of the oil industry". But her remarkable journalism nor her legacy as a trailblazer for women in the industry that got her on this list. Wanda played a critical role in the formation of one of the world's most influential oil organizations: OPEC.

In 1959, tensions soared between international oil companies and oilexporting countries. Russia had returned to international oil markets and supply was climbing faster than demand. The result was a price war that saw oil companies cut the posted price of oil - unilaterally reducing the national revenues of oil-exporting nations. At this time, the first Arab Oil Congress was taking place in Cairo. Wanda was one of the 400 people in attendance. She invited two of strongest anti-oil company individuals to a private meeting. This was the first time that Saudi Oil Minister Abdullah Tariki met Juan Pablo Perez Alfonso, Venezuela's Minister of Mines and Hydrocarbons. Her instincts were right as the two men immediately established a rapport. These men went on to organize a secret meeting with other oil ministers. It was at this meeting that the concept of an Organization of Petroleum Exporting Countries was first established.

### **IDA TARBELL**

The history of the oil industry would not be complete without the woman who took on John D. Rockefeller, the wealthiest American of all time. Ida Tarbell was an investigative journalist determined to hold the oil industry to account. Every anti-trust lawsuit or environmental claim brought against the oil industry since her time is built on her legacy.



During her journalism career, Tarbell wrote biographies of both Napoleon and Lincoln, but is most famous for her 1904 book titled "The History of Standard Oil." The book was described as a "masterpiece of investigative journalism", detailing how Standard Oil used its wealth, power, and a vast intelligence network to put pressure on independents and other competitors. She wrote that Rockefeller had "systemically played with loaded dice" and painted him, in the words of Daniel Yergin, as an "amoral predator". Tarbell's work led to dissolution of the world's largest oil company and, in time, the birth of the U.S. oil majors that we know today.

# U.S. Energy Leadership Key to National Security, Economic Strength and Climate Progress (api.org)

WASHINGTON, November 29, 2023 – American Petroleum Institute (API) Executive Vice President and Chief Advocacy Officer Amanda Eversole today testified before a U.S. House Committee on Energy and Commerce subcommittee, highlighting the critical role of American energy leadership in strengthening national security, supporting economic prosperity and advancing innovation to accelerate climate progress.

"America's vast energy resources are the foundation for security and economic prosperity, in this country and around the world," Eversole said in submitted written\_testimony. "In a time of tremendous geopolitical uncertainty, American energy has been a reliable source of strength for our allies abroad and a foundational asset to developing nations working to escape energy poverty."

Eversole highlighted how American innovation spurred the shale revolution, transforming the energy landscape in the U.S. Today, U.S. CO2 emissions from the domestic power sector have fallen to their lowest levels since the 1980s, and cleaner fuels have helped lower tailpipe pollutants by 99% since the 1960s.

"The shale revolution didn't happen by accident. It was the product of innovation and investment that can only happen in a society of free markets, where government policies don't suppress innovation and stand in the way of energy production," Eversole said. "The U.S. oil and natural gas industry knows how to solve big and complex problems, and that is exactly what we will continue to do, with innovation leading the way."

Eversole underscored how American energy is a stabilizing force. When Russia invaded Ukraine and upended global energy markets, the U.S. surged more than 800 LNG cargoes to Europe – a 141% increase over 2021.

"Lessons from the past match lessons from the present. Russia's war against Ukraine – on the heels of a brutal pandemic – created new, frequently uncomfortable norms for energy and foreign policy," Eversole said. "America must, to the greatest extent possible, lead on energy." "American energy is writing a remarkable, game-changing chapter in the story of our nation's future," Eversole concluded. "If our nation's leadership is to grow, Washington must enact policies that support increased oil and natural gas investment, exploration, and production as part of a balanced and reliable energy mix."

API represents all segments of America's natural gas and oil industry, which supports more than 11 million U.S. jobs and is backed by a growing grassroots movement of millions of Americans. 

## **Pecan Pie Cookies**

### Ingredients

### Cookie Base

- 1 pouch (17.5 oz) Betty Crocker™ Sugar Cookie Mix
- 1 tablespoon all-purpose flour
- 1/2 cup butter, softened
  - 1 egg

### **Pecan Pie Filling**

- 1 egg, beaten
- 1/3 cup packed brown sugar
- 1/4 cup corn syrup
- 1/2 teaspoon vanilla
- 1 1/2 cups coarsely chopped pecan halves

### Steps

- Heat oven to 375°F. Grease 24 regular-size muffin cups with shortening; lightly flour.
- 2 In large bowl, mix Cookie Base ingredients with spoon until soft dough forms. Using rounded tablespoonfuls of dough, shape dough into 1 1/4 to 1 1/2-inch balls; place in muffin cups. With thumb, make indentation in center of each. Bake 8 to 10 minutes or until light brown.
- 3 Meanwhile, in medium bowl, mix Pecan Pie Filling ingredients until well blended.
- 4 With end of wooden spoon, reshape indentations in center of each cookie to create 1 1/2-inch opening in partially baked cookie cups. Clean off end of wooden spoon with paper towel as needed. Stir filling to redistribute nuts; spoon 1 tablespoon filling into each cookie cup, stirring before filling each.
- 5 Bake 8 to 10 minutes or until edges are golden brown. Cool 10 minutes in pan on cooling rack. Run knife around edge of each cookie cup to loosen. Cool completely in pan, about 30 minutes. Remove cookie cups from muffin cups.
